- 3. The School shall admit in Class I, to the extent of 25% of the strength of that class, children belonging to weaker section and disadvantaged group in the neighbourhood and provide to them free and compulsory elementary education till its completion, Provided, further that in case of Pre-Primary classes also, this norm shall be followed.
